

## DESCRIPTION:

**Truck Wash Heavy Duty** is designed to remove road film, exhaust residues, bugs, dirt and grime from trucks, trailers, machinery, caravans and boats. Good for cleaning curtain sided vehicles.

## DIRECTIONS:

Truck Wash works best on cool surfaces. Hose away any dirt from the vehicle prior to applying the Truck Wash.

**By Brush or Sponge:** Dilute 1 part **Truck Wash** with 100 parts of water in a bucket. Wash the vehicle and then rinse the suds off with clean water.

**By Water Blaster:** Dilute 1 part **Truck Wash** to 25 parts of water and spray on the vehicle, allow it to penetrate the dirt and grime for up to 5 minutes before rinsing off with clean water at high pressure.

The Truck Wash dilution rate maybe altered to suit your vehicle needs.
